**THE CODE OF CRIMINAL PROCEDURE AMENDING LAW,  
1973****[The Union of Burma Revolutionary Council Law No. 2 of 1973]**

The Revolutionary Council of the Union of Burma make the following Law :—

1. (1) This Law shall be called the Code of Criminal Procedure Amending Law, 1973.
- (2) This Law shall come into force at once.
2. In the Code of Criminal Procedure, hereinafter referred to as the said Code, the provisos to section 408 *shall be deleted*.
3. Section 438 of the said Code *shall be deleted*.
4. In Section 439 of the said Code—
  - (a) in sub-section (1), the words “or which has been reported for orders,” *shall be deleted* and *after* the words “the High Court” the words “the State or Divisional Court” *shall be inserted* ;
  - (b) in sub-section (2), the words “either before the High Court or before the Sessions Judge or District Magistrate who reported the case for orders under section 438 : Provided that when a Public Prosecutor appears in the High Court to support the reference the accused shall be entitled to be heard before the High Court” *shall be deleted* ;
  - (c) in sub-section (4) *after* the words “the High Court” the words “the State or Divisional Court” *shall be inserted*.
5. In section 442 of the said Code, *after* the words “the High Court” the words “the State or Divisional Court” *shall be inserted*.

6. All appeals filed under proviso (b) or proviso (c) to section 408 of the said Code and all revision proceedings opened in pursuance of reports made under section 438 of the said Code and which, immediately before the coming into force of this Law, are pending in the Supreme Court shall be deemed to have been transferred to the respective State or Divisional Court for hearing or disposal.
